**INTRODUCTION:** In 2016, the Council declared a list of properties the City has accumulated over the years as surplus. Muscatine County has had a number of properties they too have accumulated in the City from delinquent taxes.

**BACKGROUND:** The County has reached out to the City to deed these tax delinquent properties to the City for final disposition. Attached is a list of these vacant properties... none of them have buildings on them.

On May 1<sup>st</sup>, the County has approved this list subject to the City Council's acceptance of them. Staff is requesting the additional step to accept and declare them as surplus so we may add them to our list of available properties we can properly dispose of either by sale or trade.

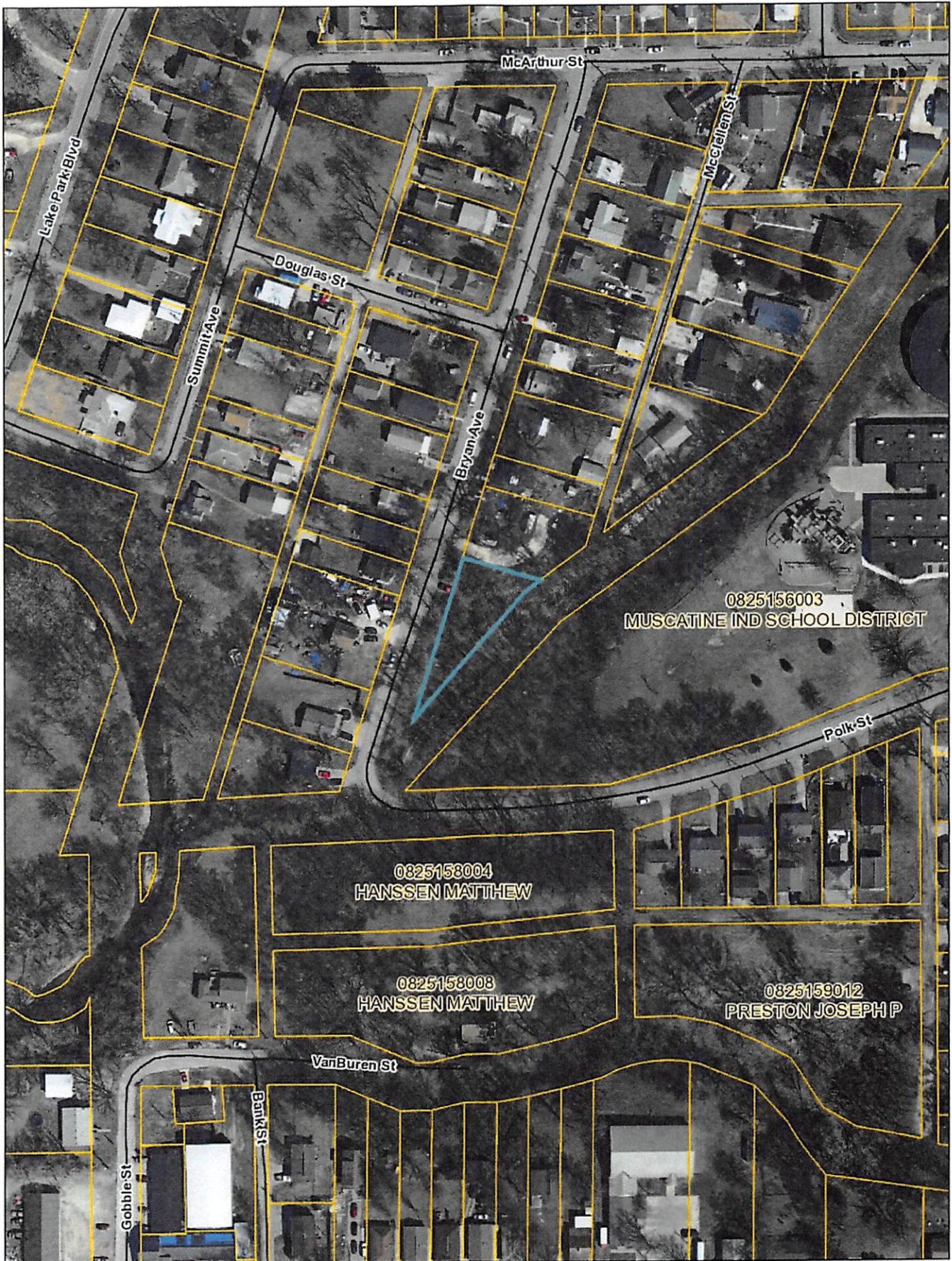
