SUBJECT: City Council Agenda Item – Request Road Closure for Training Burn

**INTRODUCTION:**

The Muscatine Fire Department is requesting that Hershey Avenue between Ash Street and Green Street along with Green Street between Hershey Avenue and Mill Street be closed on March 25<sup>th</sup> from 7:00 a.m. through 7:00 p.m. for a large scale training fire at the former Beach Lumber site on Hershey.

**BACKGROUND:**

The Muscatine Fire Department has been afforded the opportunity to conduct a large scale live fire training event at the former Beach Lumber Company site on Hershey. This large training exercise will also include many of the county fire departments participating also.

This scheduled training burn and road closure request has been reviewed through the traffic committee. DNR notification has been made and asbestos abatement will have been remedied prior to the burn. The Fire Department will install door knockers to adjacent property owners that will be affected by the road closure and training fire. This event will also be broadcast through various forms of social media.

In order to provide for the utmost safety of the training participants and the public as a whole, the department is requesting the closure of Hershey between Ash and Green Street and Green Street between Hershey and Mill on March 25<sup>th</sup>.

**RECOMMENDATION/RATIONALE:**

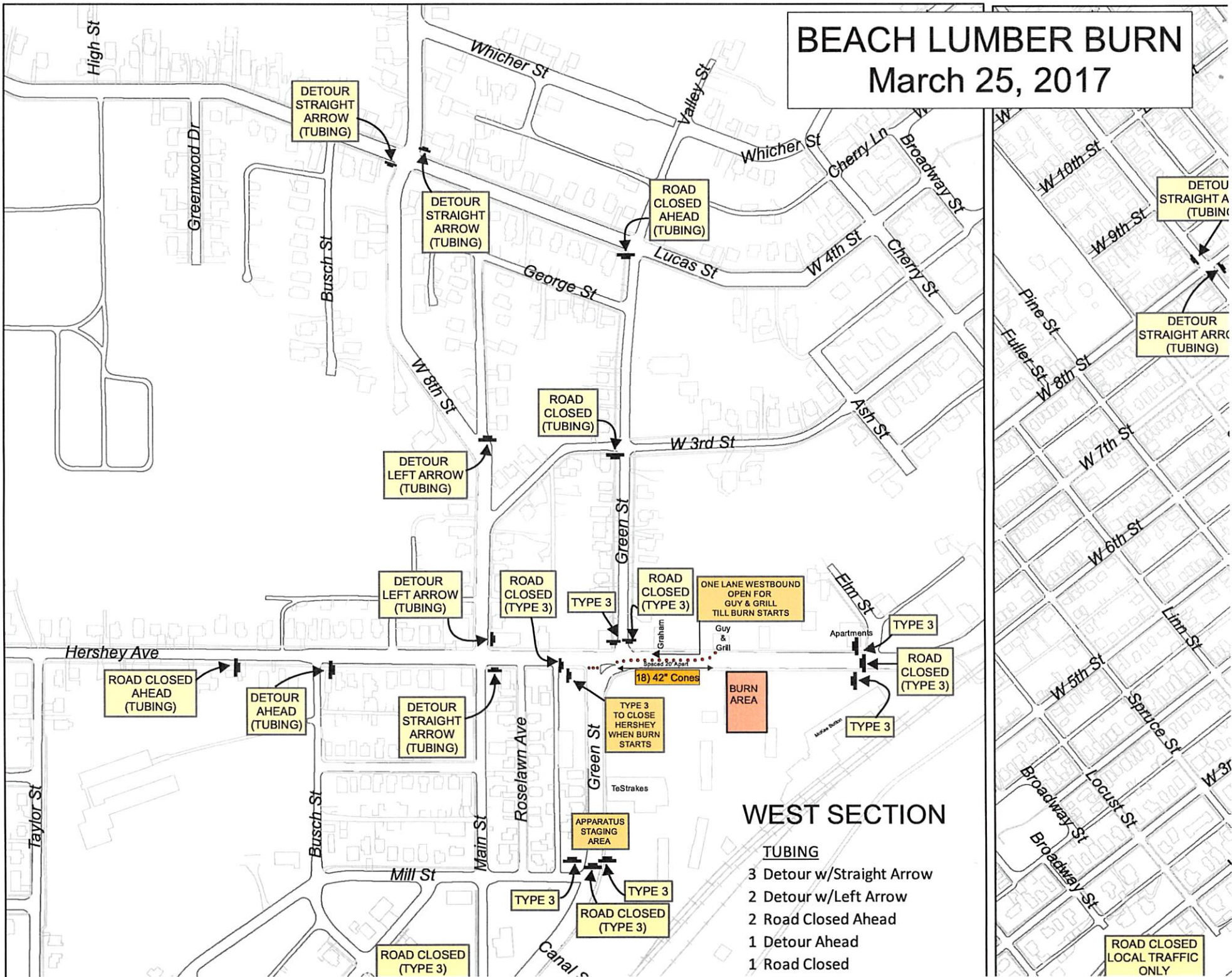
