Re: Annual Street Finance Report

Introduction and Background:

Annually cities in Iowa are required to complete and submit to the Iowa Department of Transportation (IDOT) the City Street Finance Report showing all street-related expenditures and related funding sources. The attached report is for the fiscal year ended June 30, 2018 and includes all of the forms required by the IDOT.

Report Highlights:

Street-related expenditures for the year totaled \$12,986,076. This includes \$12,538,503 paid from City funds and funding sources and \$447,573 of street lighting costs provided by Muscatine Power & Water. City paid expenditures include \$2,503,627 of street-related costs accounted for in the General Fund, a total of \$8,647,333 for street-related capital projects, and \$1,387,543 for debt service principal and interest on the street-related portions of outstanding bond issues. The capital projects funding amount includes \$7,513,668 for the Mississippi Drive Corridor reconstruction project, \$1,011,319 for the annual street resurfacing program, \$58,623 for railroad crossing improvements, \$22,807 for the Mulberry Avenue reconstruction, and \$40,916 for various other projects.

A major funding source for street expenditures is Road Use Tax funds which totaled \$3,037,921 for the year. Federal and State grant funds totaled \$48,430 with \$30,000 for Mulberry Avenue, and \$18,430 related to the Mississippi Drive Corridor project. Local Option Sales Tax funds of \$580,843 were used for pavement management projects. Other contributions for capital projects included \$1,000,000 from the Canadian Pacific Railroad for Mississippi Drive, and \$1,092,116 from Muscatine Power & Water for utility work on Mississippi Drive. Property taxes of \$1,387,543 funded the principal and interest payments due on the street portions of previous bond issues.
