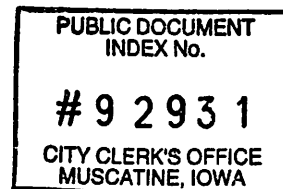

RE: Request Approval to Purchase Zero Turn Mower for Cemetery



INTRODUCTION:

Please accept this memo and the attached information as a request for approval to purchase a Zero Turn Mower for Cemetery Division as requested and approved in the current budget.

BACKGROUND:

The requested Zero Turn Mower as explained in the attached memo from Randy Moeller, Park Maintenance Supervisor, will replace a worn out unit that no longer works. Greenwood Cemetery is an 80 acre cemetery that the Parks and Recreation Department maintains.

RECOMMENDATION:

In accordance with the City's Purchasing Policy qualified responsive and responsible vendors were solicited to submit a bid. We received eight (8) bids that met the minimum requested specifications. The bid results are on the attached memo. At this time, the City Staff would recommend that the City Council approve the purchase of the Zero Turn Mower from Sinclair Tractor, Muscatine, Iowa in the amount of \$7,760.04.

The FY 2014/15 Budget had \$9,000.00 approved for this piece of equipment.

SUBJECT: Purchase of Zero Turn Mower for the Cemetery

In the FY 14-15 budget there is \$9000.00 approved to purchase a replacement mower for the Cemetery. Bids were sent out and made available on the internet with 8 bids being submitted.

The results are as follows:

After reviewing all of the bid results, I recommend that we purchase the mower from Sinclair Tractor in Muscatine for \$7760.04. The mower is under the \$9000.00 that is budgeted and meets our needs and specifications.

This mower purchase will keep the Cemetery equipment current and following a rotation that will allow us to keep the grounds maintained at a high level.
