Join us at City Hall to support saving the Steps

At one time there were four concrete stairways from the bottom of the bluff to the top. These public rights of way provided safe pedestrian corridors from the South End to the top of the bluff. Now only two are left. Both are unique gems which add to the historic appeal of our town. One is the Cherry Street Steps from West Second Street up to the foot of Cherry Street. They are still being used and are in good repair. Another is the Cemetery Steps from Hershey Avenue up to the Greenwood Cemetery. Until just a few years ago the Cemetery Steps were also in good condition and were well-used, especially by young people, walking to and from school and school activities. The Cemetery Steps were also an important pedestrian route from the West Hill Area to and from the Riverfront, South End businesses, and Kent Stein Park. They were the only safe pedestrian walkway west of the Main Street-8th Street hill. Unfortunately maintenance of the Cemetery Steps was neglected, the steps fell into disrepair and were closed by the city. At that time only minor repairs were needed. Due to continued neglect the damage has become more serious, but most of the stairway is still in sound condition. It appears that someone recently removed about a dozen steps at the top, so that the stairway is not as easily accessed as it once was. There are a couple of places lower down which need work, and the handrails need to be replaced. With some repairs and a little continued maintenance the Cemetery Steps could easily last another century.

Mr. Mayor, Administor, and Alderman

I would like to express my support for restoring the Greenwood Cemetery stairway. Many of the younger folks in Muscatine aren't aware it exists, or the historical significance it has.

Sometime in the past the steps fell into disrepair and the City neglected to maintain them when their upkeep would have been minimal. However, if corrective action isn't taken in the very near future the steps will continue to deteriorate to the point that repair costs will be prohibitive. The "Closed, or no trespassing" signs will not excuse the City of liability should someone get hurt on the steps in their current condition. The liability will probably exist until they are either repaired or completely removed. No doubt the cost of repair will be considerable, however, the cost of removal and taking the necessary precaution to stabilize the hillside from erosion will also amount to a substantial expense.

Please give your consideration to preserving this bit of Muscatine history. This stairway dates back to a time in Muscatine when a person's feet were their primary means of transportation. It is my opinion that the money will be better spent in repairing the stairway than it will be tearing it out. Perhaps a portion of the restoration cost could be offset with private funding?

At one time there were four concrete stairways from the bottom of the bluff to the top. These public rights of way provided safe pedestrian corridors from the South End to the top of the bluff. Now only two are left. Both are unique gems which add to the historic appeal of our town. One is the Cherry Street Steps from West Second Street up to the foot of Cherry Street. They are still being used and are in good repair. Another is the Cemetery Steps from Hershey Avenue up to the Greenwood Cemetery. Until just a few years ago the Cemetery Steps were also in good condition and were well-used, especially by young people, walking to and from school and school activities. The Cemetery Steps were also an important pedestrian route from the West Hill Area to and from the Riverfront, South End businesses, and Kent Stein Park. They were the only safe pedestrian walkway west of the Main Street-8th Street hill. Unfortunately maintenance of the Cemetery Steps was neglected, the steps fell into disrepair and were closed by the city. At that time only minor repairs were needed. Due to continued neglect the damage has become more serious, but most of the stairway is still in sound condition. It appears that someone recently removed about a dozen steps at the top, so that the stairway is not as easily accessed as it once was. There are a couple of places lower down which need work, and the handrails need to be replaced. With some repairs and a little continued maintenance the Cemetery Steps could easily last another century.
