**INTRODUCTION:** A request is made to issue a purchase order to Terry & Sons of Muscatine to paint the city hangar, formerly identified as HNI Hangar No. 1.

**BACKGROUND:** During the spring of 2009, the City was notified by HINI that they would be vacating one of their two hangars located at the Muscatine Airport. In accordance with the lease between the City and HNI, the hangar was to be transferred to the city if it was no longer needed for corporate uses(s). Since that time, the exterior paint on the hangar has deteriorated and is peeling badly. City Council approved \$6,300.00 in funding to have the hangar re-painted during the current fiscal year.

**RECOMMENDATION/RATIONALE:** Two quotes have been received for this project. The City Council is requested to authorize the issuance of a purchase order to Terry & Sons, Inc., of Muscatine, in the amount of \$6,225.00 for the re-painting of the City Hangar (formerly HNI Hangar No. 1 at the Muscatine Municipal Airport.
