INTRODUCTION:

Prior to each deer hunting season and according to City Code Title 7 Police Regulations, Chapter 24 Weapons, Section 7-24-5 Bow Hunting Deer, Item A "The hunt shall be authorized by action of the Muscatine City Council prior to October 1 of each year, during the time when such hunting is allowed by the law and regulations of the State of Iowa."

MEMORANDUM

BACKGROUND:

Since the 2006-07 Deer Hunting Season, the City of Muscatine has participated in a City wide deer hunt program with the guidance of the Iowa Department of Natural Resources. Attached you will find the 2010 City Deer Hunt Report. The report will show that we have experienced minimal issues while successfully managing our deer population.

If approved, this year's hunt will again be for bow hunting on approved private property and will run from Saturday, September 10, 2011 through Sunday, January 29, 2012. The required proficiency test will be for the hunter to successfully shoot 3 of 5 arrows in a 5 inch circle from a 20 yard distance. Only two chances will be allowed in one day.

RECOMMENDATION:

At this time, the City staff would recommend that the Muscatine City Council approve the 2011-12 City Deer Hunt as outlined in the City Code Title 7 Police Regulations, Chapter 24 Weapons.

TITLE 7 POLICE REGULATIONS

CHAPTER 24

WEAPONS

SECTIONS:

- 7-24-1 Discharging Firearms
- 7-24-2 Missiles
- 7-24-3 Carrying of Weapons
- 7-24-4 Peace Officers Exception
- 7-24-5 Bow Hunting Deer Exception
- 7-24-1 <u>Discharging Firearms.</u> It shall be unlawful for any person to discharge any firearm, B.B. gun, pellet gun, bow and arrow, sling shot, or any other device which discharges a projectile, within the Corporate Limits of the City of Muscatine, except on a recognized target range.
- 7-24-2 <u>Missiles</u>. It shall be unlawful for any person to throw any missile upon any street, alley, or public place, or to shoot any bow and arrow, B.B. gun, pellet gun, sling shot, or any other device which discharges a projectile so that said projectile crosses a public street, alley, public place, or real property boundary.
- 7-24-3 <u>Carrying of Weapons</u>. It shall be unlawful for any person to carry or display any weapon, loaded or unloaded, in a threatening manner, real or implied, on any street, alley, public place, or private property.
- 7-24-4 <u>Peace Officers Exception.</u> Nothing in this Chapter shall be construed to prevent peace officers from using their weapons in the performance of their duties.
- 7-24-5 <u>Bow Hunting Deer Exception.</u> It shall not be deemed a violation of this chapter to use a bow and arrow to hunt deer on parcels of two (2) acres or more with the following conditions:

7-24-5

(A) The person is the owner of the property or has permission from the owner to allow for bow hunting.

- (B) The person bow hunting must successfully complete a proficiency test as approved by action of the Muscatine City Council.
- (C) The person has a license or permit required by the State of Iowa to hunt deer with a bow.
- (D) The person has a permit issued by the Muscatine City Clerk.
- (E) The hunt shall be authorized by action of the Muscatine City Council prior to October 1 of each year, during the time when such hunting is allowed by the law and regulations of the State of Iowa.
- (F) Hunting shall not occur within one hundred fifty (150) feet of any residence, church, or occupied structure.
- (G) The hunt shall be limited to the sex of the deer allowed by the laws or regulations of the State of Iowa and as allowed by action of the Muscatine City Council.
- (H) The person hunting must demonstrate compliance with these requirements to any law enforcement officer upon request.
- (I) Persons wishing to participate in this program are required to attend an informational meeting held by the City of Muscatine in advance of the designated season.
- (J) With the permission of City Council, designated public property may be used during the designated hunting season.
- (K) Property owners with adjoining lot lines will be permitted to combine properties to reach the minimum two (2) acres required for hunting and there will be no zoning restriction on this acreage.

SUBJECT: 2010 City Deer Hunt Report

Please accept this memo and the attached information as a summary report for the 2010-11 City of Muscatine Deer Hunt Program.

As you are aware, since the 2006-07 deer hunting season, the City of Muscatine has participated in a Deer Management Zone program guided by the Iowa Department of Natural Resources. The total deer harvest results are listed below with specific results attached.

In February 2011 an aerial count was conducted by the Parks staff and IDNR officials. The count is summarized below and attached for your review. Basically, the recent flyover shows that our deer population increased from 2010 to 2011 by 6 deer. IDNR officials have documented that deer population normally increases by one-third. Our population increased by 6 instead of the norm of 36. There is a + or -10% factor depending on flyover conditions and ground cover.

The 2010-11 program details are as follows:

- > The pre-season hunter meeting took place on August 25, 2010 with 28 hunters in attendance. The IDNR officer was also in attendance.
- > The qualification dates for bow hunting proficiency were August 28, September 1, and September 4. Special times were scheduled as groups could be coordinated with available staff times. There were a total of 50 hunters tested with 49 passing. The test was for the hunter to successfully shoot 3 of 5 arrows in a 5 inch circle from a 20 yard distance. Only two chances were allowed in one day.
- > The actual City of Muscatine's Deer Management Zone Hunt was September 12, 2010 to January 31, 2011. The zone hunt is greater in length than the normal state wide hunting season.
- > A total of 200 deer tags were available to hunters wishing to participate. The tags were available at the County Recorders office. The first tag purchased by a hunter was \$27.00 and all additional tags were \$12.00.
- > A total of 17 hunters took the 27 deer killed in this season's hunt (22 doe, 1 buck, 1 button buck).

A community survey was conducted with limited response. Of the responses we received the following suggestions were made: could not get a tag when wanted one, should re-designate city parks again, buck tags should be given by a draw system instead of most kills in previous year,

have residents who want hunters to contact the City for hunting availability, better communications, encourage hunters to cooperate with each other, regulate hunting open for parks and cemetery. The survey results are attached for your review.

There were three issues reported to me this deer season and are listed below:

- 1. A property owner refused to let a hunter retrieve his deer from his property.
- 2. A hunter refused to report to us where the deer was killed.
- 3. A hunter went onto private property to hunt without approval from the property owner.

In summary, the 2010-11 City of Muscatine Deer Management Zone was successful in that it allowed for the elimination of the deer population to a number greater than the normal deer population growth standard. Greg Harris, the IDNR Deer Deprivation Officer communicated to me that we are accomplishing our goal and that we are now in a maintenance mode instead of an eradication mode.
