Please accept this memo and the attached information as a request from Mr. David Moritz representing Muscatine Boat Show 2010 to use the Muscatine Riverfront from May 14, 2010 to May 16, 2010 for the 4th Annual 'That Was Then, This Is Now' 2010 Boat Show.

BACKGROUND:

The request submitted by Mr. Moritz will require the closing of the Muscatine Riverfront from Cedar Street to Iowa Ave. exclusive of Cedar Street due to boater access to the harbor and new boat launch area. The event sponsor has been very responsible in the past, and the community has participated heavily. Due to the request to close the Riverfront for normal activities, this request will need the City Council's approval.

RECOMMENDATION/RATIONALE:

At this time, City staff would recommend that the City Council approve the request as submitted for the 2010 Muscatine Boat Show. Additionally, the Muscatine Recreation Advisory Commission at the January 2010 regular meeting fully endorsed the request to use the Muscatine Riverfront for this event.
