The recently formed Muscatine Housing Cluster is accepting grant applications until 5 p.m. August 12, 2009. A completed application (see attached) was submitted to the cluster this afternoon, seeking \$7000 in funding assistance for the Muscatine Housing Rehab Program.

Although the rehab program is primarily financed through a \$264,162 Community Development Block Grant (CDBG) award, additional funding would be helpful. The LHTF revenue could be used for projects that exceed the maximum \$37,500 allowed under the CDBG program; and to cover expenses that might not be allowed under the primary program.

Funding awards are expected to be announced in November. This will not require any match of city funds. The \$7800 identified as City of Muscatine funds in the proposed budget is funding previously committed under the 2009 CDBG grant award. Those funds come from budgeted salary expenditures.

The City of Muscatine proposes to leverage Muscatine Local Housing Trust Fund (LHTF) grant resources with existing Community Development Block Grant (CDBG) funds to assure complete rehabilitation of owner-occupied housing within a targeted area of Muscatine. Existing CDBG regulations limit the amount of funding available through that program to \$37,500 per residence. In some cases that is not sufficient to complete all the needed repairs. An LHTF award will be used to cover remaining expenses.

6. Description and history of organization:

The City of Muscatine has conducted housing rehabilitation and similar assistance programs for nearly 50 years. The city's involvement with administration of CDBG awards dates back to the start of that program. From 1978 to 1994, over \$12 million in funding assistance was administered by the city's community development department for housing rehab and other revitalization work,

During this time, 218 single-family homes received assistance. Throughout the mid-1990s, the department also administered a \$1.4 million grant to build 15 single-family residences at scattered infill sites throughout the community.

Muscatine has received four Housing Fund grants since 2000. All of this funding comes from the CDBG program administered by the Iowa Department of Economic Development (IDED) The 2000 grant award of \$315,000 helped rehabilitate 12 homes in the city's Tree of Hope and Midtown H.E.A.R.T. neighborhoods. In 2003 the city received a \$392,862 award to continue working in those neighborhoods and two other adjoining neighborhoods. Eleven homes were rehabilitated in that project, which was completed in November 2005. A 2006 Housing Fund award of \$415,788 was used by the city to rehabilitate 12 properties in the Riverbend Neighborhood. The completion date for the 2006 program was August 30, 2008.

In 2009, the city received its fourth Housing Fund award of \$264,162. This funding will be used to rehabilitate a minimum of seven properties. The target area for the 2009 rehab program includes the 2006 area, plus an additional area of Hershey Avenue, Green Street, George Street, Evans, Mill and a neighborhood between Taylor and Green Streets.

8. Project Description: Give a more detailed description of the project

The City of Muscatine was awarded a \$264,262 Community Development Block Grant (CDBG) in 2009 to rehabilitate a minimum of seven homes in a targeted area around Hershey Avenue. The 2009 program was a continuation of a similar rehab program conducted in the same general area between 2006 and 2008.

The intent of the CDBG Housing Rehab Program is to upgrade the condition of owner-occupied housing to make it "safe, decent and sanitary." Under the CDBG program, each property can be awarded up to \$24,999 for rehabilitation work. Other funding is available to conduct interim control of lead-based paint. A maximum of \$37,500 can be spent on each property. That amount includes all rehab, lead-based paint, administrative and other costs,

Despite this level of funding, not all of the necessary work can be completed on some of the properties within the \$37,500 limit. In those cases, either some work must be deleted; or the owner must cover the cost overrun. All the property owners must be at or below 80% of the median income limit; and in most cases, they are significantly below that threshold. The LHTF revenue would be used to supplement and leverage the CDBG assistance; and cover costs not covered by that funding.

The current two-year CDBG contract runs until June 2011. One property has already been completed and another is in progress. A contract for a third property will be signed on August 13, 2010 and two other properties are currently being processed in the first steps towards actual work.

Muscatine's 2009 CDBG Housing Rehab started in June 2009. Initial work included development of an environmental record and screening and ranking of pre-applications. As a property comes to the top of the list, the property is inspected, work specifications are developed and bids received. Once all the work is satisfactorily completed, the project is closed out. The owner must then remain in the house for for five years or repay a portion of the grant/forgivable loan. The entire process, with the exception of the five-year period, has been completed on one of the seven projects.

12. Justification for Funding.

Although the city received a substantial amount of funding through the Community Development Block Grant, that award is limited by federal guidelines. Under those rules, the maximum amount of funding available is \$24,999. Some funding is available to interim controls for lead-based paint, administrative expenses and other costs. The maximum that can be spent on any one property is \$37,500. If the rehab costs exceed this threshold, the owner must either provide the difference or the project scope must be reduced. Under either option, the property owner - who will definitely be at or below 80% of the median income and most likely even lower – often cannot afford to pay the extra cost. That means the project scope is reduced, which could lead to a substantial reduction in the project's overall property improvement objective.
