

E. Resolution Authorizing the Assessment of Unpaid Nuisance Abatement Costs to Private Properties

Presented for City Council's consideration is a resolution authorizing the assessment of unpaid abatement costs to private properties. The nuisance abatement costs total \$3,863.20, the administrative fees are \$600.00 and the assessment fees are \$1,150.00. The total fees being requested for assessment at this time totals \$5,613.20.

F. Resolution Awarding Contract for the 2019 Asphalt Alley Program

Presented for City Council's consideration is a resolution awarding the contract for the 2019 Asphalt Alley Program to Taylor Ridge Paving and Construction in the amount of \$208,459.59. Five bids were received and the low bidder does not meet the bid specifications, staff recommends awarding bid to the second lowest bidder, Taylor Ridge Paving and Construction.

Presented for City Council's consideration is a request to accept the bid price of \$59.98 per ton for road salt from the City of Davenport. Because of the brutal winter and the low stockpile of rock salt we have ordered 3 barges full totaling \$269,910.00. There is \$220,000 budgeted for this purchase.

I. Request to approve the issuance of a purchase order for replacement of Trailer #13 walking floor.

Presented for City Council's consideration is a request to approve the issuance of a purchase order to Jim Hawk Trailer, in the amount of \$23,552.46 plus freight cost, for the replacement of walking floor in trailer #13. This is not a budgeted item, but is necessary for transfer station operations. This will be included in the revised estimate for the 2019/2020 budget.

Presented for City Council's consideration is a request to approve the issuance of a purchase order to Terry and Sons Painting, in the amount of \$27,484.00, for painting of the Muscatine Aquatic Center pool basin. Three Bids were received and Terry and Sons was the lowest bid. There is \$30,000 budgeted for this expense.

K. Request to approve the issuance of a purchase order for a Riding Rotary Mower for the Muscatine Soccer Complex

Presented for City Council's consideration is a request to approve the issuance of a purchase order to MTI Distributing, in the amount of \$73,360.53, for the purchase of a Toro 4700D Riding Rotary Mower for the soccer complex. There is \$82,000.00 budgeted for this purchase.

Presented for City Council's consideration is a request to approve the issuance of a purchase order to Sinclair Tractor, in the amount of \$44,072.32, for the purchase of a John Deere tractor for Greenwood Cemetery. Five bids were received and the lowest bid that met the specifications was from Sinclair Tractor in Muscatine. There is \$42,000 budgeted for this purchase. The overage will be paid out of the savings on the mower purchase.

Presented for City Council's consideration is a request to approve the City of Muscatine's General Contractor Agreement. Two bids were received with the low bid from BMW Builders II. The agreement would be in effect from July 2019 through June 30, 2022, with a possible one-year extension.

## Item 11N

Councilmember Saucedo requested a discussion regarding a change in City Code Title 1, Chapter 10, Section 2 E1b. He stated that current code does not allow for Councilmembers to discuss projects, progress and purchases with department heads or staff members.

Councilmember Brackett stated he supports this change, not to give orders to staff but to be able to communicate and receive feedback.

Mayor Broderson read a letter submitted by Councilmember Malcolm stating he is in support of this change.

Councilmember Spread stated he does not feel this change is necessary. He stated that if transparency is the issue how is a one on one conversation transparent.

Councilmember Brockert stated that she supports the change.

Councilmember Spread stated that he does not support the change. He stated that he has not had any trouble with the current code and communication during his time on City Council.

City Administrator Mandsager stated that by changing this code there are other issues that would be affected and the City would need to work with City Attorney on the changes.

There was other discussion between City Council members and staff regarding the change.

There was a consensus with City Council to bring this issue back to Council on August 15, 2019, and to discuss the changes with the City Attorney at said meeting.

### **Communication-Council Members**

Councilmember Harvey reminded businesses that it is City Staff's obligation to enforce rules and regulations and not to change them.

Councilmember Saucedo thanked everyone that made the first Almost Friday Fest a success.

Councilmember Brackett thanked everyone involved in Rockin on Sycamore for raising money for Shop with a Cop.

Mayor Broderson stated Coffee with the Mayor has been cancelled due to the heat and that she will be on vacation for the next week. Mayor Broderson reminded citizens to check on family members and neighbors during this heat spell.
