Ms. Stafford stated some of the popular programs implemented in 2020 included Muscatine Mystery Mail, Virtual Fishing Derby, Treasure on the Trails and Trunk or Treat under the lights. Ms Stafford also stated that she had developed a Virtual Recreation Resource Center to give citizens new ideas and to help them stay active under the COVID restrictions. Ms. Stafford stated that Muscatine had received National Recognition due to the programs created by the Muscatine Parks and Recreation Staff.

Kate Schoemaker, Sr. Account Executive, Global Expansion was present to give a brief demonstration regarding bringing bird scooters to Muscatine. Ms. Schoemaker shard stories from other cities regarding the use of the scooters and encouraged Muscatine to consider them as well. There were questions and discussion regarding the changes that would need to be made within the City Code in order to comply with regulations. Other concerns raised by City Councilmembers included permits, rule enforcement, rider training and city liability.
