SUBJECT

Third and Final Reading of An Ordinance Vacating the Undeveloped Lombard Street Right of Way

EXECUTIVE SUMMARY

Presented for City Council's consideration is an ordinance vacating the undeveloped Lombard Street right of way. The City of Muscatine received a request to vacate the undeveloped Lombard Street right of way and Deed said right of way to the adjoining property owner. The adoption of this Ordinance on third and final reading will complete the vacation of the Lombard Street Right of Way.

STAFF RECOMMENDATION

Staff recommends approval of the attached ordinance to vacate the undeveloped Lombard Street right of way.

BACKGROUND/DISCUSSION

In June of 2019, Patrick Garrels, owner of Garrels Enterprise, LLC, Purchased 1100 E. 7th Street from Andy Hartsock. This property is currently a rental property. Mr. Hartsock would like to construct a garage on this property in the future.

CITY FINANCIAL IMPACT

This portion of the public right of way serves no current or anticipated future public use. This action will eliminate any future financial impacts of ownership.
