### EXECUTIVE SUMMARY

---

The City of Muscatine Staff and Water's Edge Aquatic Design developed the plans and specifications for the Taylor Park Splashpad Project. The Muscatine City Council held a public hearing and approved the plans and specifications on February 3, 2022. Two proposals were received by the due date of March 8, 2022. Please see the attached bid tab for the bid results.

### STAFF RECOMMENDATION

---

City Staff and the project engineer evaluated the submitted proposals and the bid bond and found them to be responsive and recommend award of the Taylor Park Splashpad Project contract to The Henley Group, LLC in the amount of \$333,000.00.

### BACKGROUND/DISCUSSION

---

The City of Muscatine Parks and Recreation Department and the project engineer developed the plans and specifications for the Taylor Park Splashpad Project, which is part of the Community Foundation of Greater Muscatine Southend Improvement Fund Projects. The improvement fund projects were developed in collaboration with the fund steering committee and several community groups to make recreational improvements in the southend portion of the Muscatine community. The City Council approved the concept plan for the southend community improvements at their regular meeting on October 7, 2021.

### CITY FINANCIAL IMPACT

---

The costs associated with the Taylor Park Splashpad Project will be funded from the Community Foundation of Greater Muscatine Southend Improvement Fund \$2,000,000.00 private donation to the City. There was \$425,000.00 budgeted in the improvement fund for this project. The future maintenance cost impact has been minimized as much as possible through the design process.

BE IT FURTHER RESOLVED, that the Mayor and City Clerk are hereby authorized and directed to execute a contract with The Henley Group, LLC for construction of the same.
