AN ORDINANCE AMENDING TITLE 7 POLICE REGULATIONS CHAPTER 24 WEAPONS TO ADD A NEW SECTION 5 TO AUTHORIZE BOW HUNTING OF DEER WITHIN THE CITY LIMITS

Be It Enacted by the City Council of the City of Muscatine, Iowa:

SECTION 1. AMENDMENT. Title 7 POLICE REGULATIONS, Chapter 24 WEAPONS, of the City Code of Muscatine is amended to add a new Section 5 to provide as follows:

- 7-24-5 <u>Bow Hunting Deer Exception.</u> It shall not be deemed a violation of this chapter to use a bow and arrow to hunt deer on parcels of three (3) acres or more zoned agricultural or classified as agricultural by the Muscatine County Assessor or on parcels of ten (10) acres or larger that are neither zoned as agricultural or classified as agricultural by the Muscatine County Assessor with the following conditions:
- (A) The person is the owner of the property or has permission from the owner to allow for bow hunting.
- (B) The person bow hunting must successfully complete a proficiency test as approved by action of the Muscatine City Council.
- (C) The person has a license or permit required by the State of Iowa to hunt deer with a bow.
- (D) The person has a permit issued by the Muscatine City Clerk and paid the permit fee in the amount of Fifteen Dollars (\$15.00).
- (E) The hunt shall be authorized by action of the Muscatine City Council prior to October 1 of each year, during the time when such hunting is allowed by the law and regulations of the State of Iowa.
- (F) Hunting shall not occur within one hundred (100) yards of any residence, church, occupied structure or park ground.
- (G) The hunt shall be limited to the sex of the deer allowed by the laws or regulations of the State of Iowa and as allowed by action of the Muscatine City Council.
- (H) The person hunting must demonstrate compliance with these requirements to any law enforcement officer upon request.
- SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
