The opening prayer was given by Rev. Harris Knox of the Church of the Nazarene.

The Pledge of Allegiance was given.

#11561. Ald. Hansen moved to approve the minutes of the Regular Council Meeting and the Special Council Meeting of July 25, 1973 as submitted. Second Ald. Hopewell. All Ayes.

Mayor Burns reported on the Muscatine Summer Youth Program.

Mr. Ernest Wedekind, 611 Adams Street, asked about a Sewer Program.

Mr. John Schwandke of the Jaycees spoke about Bridge Pier I. He wanted to know if it will become part of Riverview Park. He also gave a resume of the Jaycee plans for renovating the Pier.

#11562. Ald. Vischer moved to refer the planning to Don Hockett and he should work with Stanleys and Mr. Schwanke to secure a plan. Second Ald. Angell. 6 Ayes. 1 Nay (Hinman).

#11563. Ald. Hansen moved to refer the letter from the Board of Supervisors concerning the Hershey Avenue Project to the City-County Liason Committee. Second Ald. Duncan. All Ayes.

#11564. Ald. Vischer moved to grant the request of Midwest Transit Lines for a 5¢ charge on transfers and the agreement be amended. Second Ald. Duncan. All Ayes.

Mr. H. Howard appeared opposing the Ordinance.

Mr. Jerry Conway, Attorney for Schmarje Tool Company, appeared for the Ordinance.

#11580. Ald. Vischer moved a stop sign at the alley by the old bridge be removed. Second Ald. Hansen. All Ayes.

#11581. Ald. Hopewell moved that traffic control signs be installed at Highway 61 and Sampson Street and that the speed limit on Houser Street be 35 miles per hour. Second Ald. Hinman. All Ayes.

#11582. Ald. Hopewell moved to place a 30 minute parking meter in front of Othmer Heating Company. Second Ald. Hansen. All Ayes.

#11583. Ald. Hopewell moved the Engineering Department make a traffic control study on Sampson Street for 30 days and give a report to the Traffic Committee. Second Ald. Hansen. All Ayes.
