**RESOLUTION ACCEPTING COMPLETED WORK PERFORMED UNDER
W. 2ND STREET RETAINING WALL PROJECT
AND AUTHORIZING FINAL PAYMENT**

WHEREAS, the City of Muscatine approved the Plans, Specifications, and Form of Contract for the W. 2nd Street Retaining Wall Project; and

WHEREAS, the City of Muscatine entered into a contract for said project with Hy-Brand Industrial Contractors for \$209,244.55 with one change order, for a total contract amount of \$211,356.55; and


WHEREAS, all work under the contract has been completed by Hy-Brand Industrial Contractors and approved and accepted by the City Engineer and appears to meet the requirements of the Plans and Specifications heretofore adopted by this Council, as evidenced by the Project Engineer's Certificate; and

WHEREAS, the amount of \$178,990.40 has been previously paid to Hy-Brand Industrial Contractors and a balance of \$30,252.19 including 5% retainage remains due and payable;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MUSCATINE, that the City of Muscatine make immediate payment of \$19,790.06 to Hy-Brand Industrial Contractors for completed and accepted work under the W. 2nd Street Retaining Wall Project thereafter make an additional payment of \$10,462.13 which is the 5% retainage thirty (30) days from the date of this acceptance.

The contractor (Hy-Brand Industrial Contractors) has completed the W. 2nd Street Retaining Wall and the project is ready to be accepted. The bid price for the work was \$209,244.55 with one change order (\$2,112.00) for a final cost of \$211,356.55. The Change Order was to extend the wall, curb and new sidewalk further west on 2nd Street. City crews will install approximately 30 feet of chain link fence on the west end and also finish shoulder work on the north side of W. 2nd. This project has gone very well considering the time constraints and the "close quarters" working conditions. The wall is stout and attractive and relieves the City of considerable risk.
