NOW, THEREFORE, BE IT RESOLVED BY THIS COUNCIL that:


1. All objections to the foregoing plans, specifications, form of contract, notice to bidders, and cost estimate are overruled.



Notice is hereby given that the City of Muscatine, Iowa, will receive sealed proposals in the office of the City Clerk, City Hall, until 3:00 p.m. on the 25th day of March, 2008, for the **2008 Maiden Lane Sanitary Sewer Project** for the City of Muscatine. At 3:30 p.m. on the same day the City's Purchasing Agent shall open the bids received and announce the results.

Bids will be reported to the City Council at the regular meeting to be held at 7:00 p.m. on April 3rd, 2008 in the City Hall Council Chambers. Said proposals shall be acted on at that time or at such later time and place as may then be fixed.

The project includes extending public sanitary sewer up Maiden Lane to serve five houses on a failing deteriorated private sewer. Sewer service laterals will be extended 10 feet inside the property for each house. The homeowners shall install the remaining service lateral length to their own house. Primary work includes installing 8" sanitary sewer, sanitary manholes, storm sewer pipe and inlet, street repair and sidewalk repair. Construction will begin in June after school is out for the summer and will be completed by August 1, 2008.

Proposals shall be submitted on a form furnished by the City and accompanied by a bid security in an amount equal to five (5) percent of the bid and shall stand as security that the successful bidder will enter into a contract for the work bid upon within 21 days after acceptance of his proposal by the City.

The City reserves the right to defer acceptance of any proposal for a period not to exceed thirty (30) calendar days and to reject any and all bids, to waive technicalities and to enter into such contract as it shall deem for the best interest of said City.



AJ –

A private orange berg sanitary sewer line exists for five homes on Maiden Lane just east of Broadway. This line is deteriorating rapidly and residents are experiencing sewage backup problems. The City of Muscatine is proposing to extend the public sanitary line west by approximately 620 feet which would make hookup for the 5 residences possible. The project will result in 3 new manholes and replacing another one (maybe two). Work will be required during non-school months as the area affected is directly adjacent to Washington School. This project will be paid with one cent local option funds available. The five properties impacted by this sanitary sewer extension currently pay the city's sewer fee. However, once the public line is made available to them a hook up fee will need to be established.

We are requesting a Public Hearing be set for the 2008 Maiden Lane Sanitary Sewer Project at the February 21st meeting. If you have any questions, please contact me.
