INTRODUCTION:

A Public Hearing will be held in the City Council Chambers on Thursday, January 20, 2011 to discuss the Hershey Ave. Reconstruction Project. Following the Public Hearing a Resolution Approving the Plans, Specifications, Form of Contract, Cost Estimate and Setting a Bid Opening Date will be acted on by Council.

BACKGROUND:
