**A RESOLUTION SETTING THE TIME AND PLACE TO CONDUCT A PUBLIC HEARING ON THE PLANS, SPECIFICATIONS, FORM OF CONTRACT, COST ESTIMATE, AND ESTABLISHING A BID OPENING DATE FOR THE CONSTRUCTION OF IMPROVEMENTS KNOWN AS "PEARL II".**

**WHEREAS**, The City Council has for the City of Muscatine, Iowa, has undertaken several improvement projects related to the adopted Riverfront Development Plan; and

**WHEREAS**, The pedestrian plaza area of the Plan (also referred to as Pearl II) that is generally located between the extension of Iowa Avenue and the Papoose Creek Outfall on the riverfront is an important element toward the completion of that Plan; and

**WHEREAS**, a plan has now been completed for the area referred to as "Pearl II", and involves the construction of an interactive water feature, mechanical equipment building, installation of the Mississippi Harvest Sculpture, and related site improvements; and


**WHEREAS**, The City Council has directed that plans and specifications for the construction of the area referred to as Pearl II be prepared for public comment prior to their review and approval; and
