**A RESOLUTION SETTING A PUBLIC HEARING CONCERNING
AGREEMENTS TO PROVIDE AMBULANCE SERVICE IN LAKE,
BLOOMINGTON, AND PORTIONS OF SEVENTY-SIX, SWEETLAND
AND FRUITLAND TOWNSHIPS IN MUSCATINE COUNTY, IOWA**

RESOLVED BY THE CITY COUNCIL OF MUSCATINE, IOWA, as follows:

1. The City Council of Muscatine, Iowa, is considering entering into Agreements with Lake, Bloomington, and portions of Seventy-six, Sweetland and Fruitland Townships in Muscatine County, Iowa, to provide paramedic level ambulance response and service for a term beginning July 1, 2005 and continuing through June 30, 2010.
2. The City Council will hold a public hearing concerning these Agreements on February 16, 2006, at 7:00 P.M. in the Council Chambers at City Hall, Muscatine, Iowa.
3. Notice of the Public Hearing will be given by publication of the Public Notice attached as Exhibit A. The notice will be published once in the Muscatine Journal, a newspaper printed, published and of general circulation in the City, not less than 4 nor more than 20 days before the meeting of the City Council at which the proposal is to be considered.


