RE: Mortgage Release Date: May 17, 2005

David and Lori Krieger, 904 E. 8th Street, participated in Muscatine's 2000 Community Development Block Grant (CDBG) Housing Fund Rehabilitation Program. Rehabilitation of their property did not require the full grant (forgivable loan) amount of \$24,999. Initially, the repairs only required \$13,694.50. That was the amount of the first mortgage. Subsequently, additional repairs became necessary, bumping the total cost to \$17,109.50. A new mortgage was signed for the revised amount. Each year 20% of the loan is forgiven, so that at the end of a five-year period, the entire loan is forgiven and the mortgage is released.

However, the first mortgage should have been released upon the signing of the second (revised) mortgage, but this was not done, resulting in two mortgages being placed on the property.

The couple now wishes to refinance their home and both mortgages have shown up on the abstract. The city council is requested to approve a resolution authorizing the mayor and city clerk to sign a Release of Mortgage for the first mortgage. The second mortgage will remain in force for the portion of the five years still remaining. The Krieger's five-year period expires on November 26, 2006, at which time a Release of Mortgage for the second mortgage will be presented to the city council for action.

As an additional agenda item, the city council is also requested to approve a subordination agreement that will identify the city's remaining mortgage as secondary to the new mortgage being refinanced.

Under the terms of the contract between the City of Muscatine and the Iowa Department of Economic Development, all Housing Fund mortgages are considered secondary to any other property mortgage. The refinancing company, First Capital Financial, is requesting the city provide a formal subordination agreement that will reflect this.
