

RESOLUTION NO. 88927-1203

A RESOLUTION SETTING THE TIME AND PLACE OF A PUBLIC HEARING
CONCERNING A PROPOSED CONCESSION AGREEMENT

RESOLVED, by the City Council of Muscatine, Iowa as follows:

SECTION 1: The City Council of Muscatine, Iowa intends to enter into a concession agreement with Big Ten Concessions to provide concessions at the Muscatine Soccer Complex, Kent Stein Park and the Muscatine Aquatic Center for a period of five (5) years.

SECTION 2: The City Council of Muscatine, Iowa will hold a public hearing on the proposed agreement at 7:00pm on December 18, 2003 in the Council Chambers at City Hall, Muscatine, Iowa.

SECTION 3: The City Clerk shall give notice of such public hearing by publication of a notice in the Muscatine Journal not less than four (4) nor more than twenty (20) days, prior to the date set for the public hearing, the notice shall be in the following form:





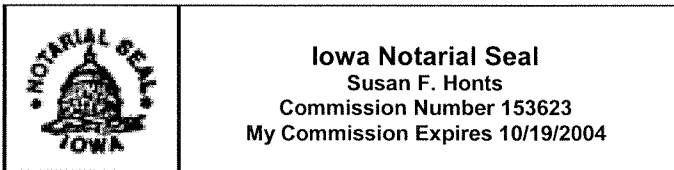
