Rada moved to approve the resolution setting a public hearing on June 5, 1980, at 7:30 p.m. on the proposal to rezone Omar Whitlow's property located off Lake Park Boulevard from R-3 Single Family Residential to M-1 Light Industrial. Second by Ald. Platt. All ayes: Ald. Platt, Koehrsen, Rada, Hilton, Kemp, Duncan and Waltman. Motion carried and resolution duly adopted.
- #4719. Ald. Waltman moved to suspend the rules and pass the ordinance on second and final reading to rezone property at the intersection of Mill, Busch, Pearl and Liberty Streets from R-3 Single Family Residential to C-1 Neighborhood Commercial and direct it to be published in the Muscatine Journal. Second by Ald. Kemp. Ayes: Ald. Platt, Rada, Hilton, Kemp, Duncan and Waltman. Nays: Ald. Koehrsen. Motion carried and ordinance adopted on second and final reading.
- #4720. Ald. Platt moved to approve the ordinance on second reading amending Sections 9-18-1 (B), 9-18-13, and 9-19-3 (I), (J) and (K) of the Zoning Ordinance. Second by Ald. Rada.
- Ald. Platt questioned why the six feet requirement was placed on the fence. Steve Boka, Building and Zoning Administrator, stated that City fence requirements now require fences to be no higher than six feet and that it was felt a lower fence might encourage children to try to climb the fences.

- #4721. Ald. Duncan moved to receive and file the letter from K & B Pools objecting to the 6 feet fence requirement for swimming pools. Second by Ald. Hilton. All ayes; motion carried.
- #4722. Ald. Waltman moved to approve the ordinance on 2nd reading to establish procedures for disposing of City property. Second by Ald. Rada. All ayes: Ald. Platt, Koehrsen, Rada, Hilton, Kemp, Duncan and Waltman. Motion carried and ordinance approved on second reading.

Mr. Clarence Johnson, 610 Liberty Street, stated that he felt citizens should not have to pay higher sewer rates in the summer for water used that does not go into the sewer such as water used for watering lawns and gardens. Ald. Kemp agreed stating that the summer sewer rates should be based on winter water usage. City Administrator Wolff stated that it would be a problem getting the necessary information on the computer as Muscatine Power and Water is still in the process of getting the City's finance system on its computer and a lot of reprogramming would be required. He added that the loss in revenue would be approximately \$30,000 to \$35,000 and the rest of the rate structure would have to be reviewed to make up the loss in revenue.

- #4744. Ald. Waltman moved to receive and file communications received with the additon of the Police Department monthly report; the letter from John Fifer, Robert and Dorothy Pape and Steve Pulliam regarding the Board of Water and Light Trustees; and the letter from John Fifer regarding the relocation claim of Donald Knapp. Second by Ald. Platt. All ayes; motion carried.

Mayor Schauland suggested that she contact Mr. Knapp concerning the relocation claim to get his feelings on the matter. Ald. Platt stated that he considered the matter closed, but that if she wished to contact him she may.

- #4745. Ald. Kemp moved to approve bills totaling \$431,967.54 and authorize the Mayor and City Clerk to issue warrants for the same. Second by Ald. Rada. All ayes; motion carried.
- Ald. Hilton reported that she had attended the Power and Water meeting last week and that a communication regarding that meeting was on their desks.
- Ald. Kemp reported that he had received a request to have some sort of warning placed on the curve going up the hill on Fifth Street and requested staff's recommendation on this.

City Administrator Wolff stated that a letter from the Iowa League of Municipalities was given to Council as a reminder for them to submit a list of items they considered of major concern for the League and legislature in the future. He added that he will compile the information and forward it to the League.

City Administrator Wolff also stated that a preliminary Capital Improvement Program for 1980/81 and the following five years was submitted to Council for their information. He added that Council will be discussing the Capital Improvement Program at the June In-Depth meeting.

City Administrator Wolff requested that Council meet in Executive Session following the regular Council meeting.

Mayor Schauland urged Council to participate in the memorial services and reminded them that Buddy Poppy Week is coming up.

#4746. Ald. Kemp moved to go into Executive Session to discuss the lawsuit concerning the property owned by Mrs. Gaeta dating back to the urban renewal

program. Second by Ald. Platt. All ayes: Ald. Platt, Koehrsen, Rada, Hilton, Kemp, Duncan and Waltman. Motion carried.

#4747. Ald. Platt moved to go out of Executive Session. Second by Ald. Waltman. All ayes; motion carried.

#4748. Ald. Platt moved to adjourn the meeting. Second by Ald. Waltman. All ayes; motion carried.
