REGULAR MONTHLY SESSION OF CITY COUNCIL

Council Chambers - January 7, 1982 - 7:30 p.m.

The meeting was called to order by His Honor, Mayor Donald R. Platt.

Julian Kite was sworn in as 1st Ward Councilmember by City Attorney Allbee.

Roll Call: Councilmembers Kite, Sayles, York, Hilton, Plett, Waltman and Brewer present.

The Opening Prayer was given by Pastor William Keller.

The Pledge of Allegiance was given.

PUBLIC HEARING

Mayor Platt announced the purpose of the public hearing was to receive public comment on the proposal to vacate and sell a portion of West 8th Street and lease a portion of Valley Street right-of-way.

There were no oral appearances for or against.

There were no written petitions for or against.

#5480. Councilmember Waltman moved to close the public hearing. Seconded by Councilmember Plett. All ayes; motion carried.

PUBLIC HEARING

Mayor Platt announced the public hearing was being held to receive citizen comment on the requests to park in the public right-of-way at 1206 First Avenue and 401 Monroe Street, and 1100 West Third Street.

Mr. Larry Day, 627 Monroe Street, owner of the property at 401 Monroe Street and Ms. Anita Hill, 1206 First Avenue spoke in favor of the request to park in the public right-of-way at 1206 First Avenue and 401 Monroe Street.

Mr. James Madden, 1100 West Third Street, spoke in favor of his request to park in the public right-of-way stating that the street is too narrow to provide adequate safe parking.

There were no written petitions for or against.

- #5490. Councilmember Waltman moved to approve the Resolution setting an administrative use hearing for Federal Revenue Sharing for January 21, 1982, at 7:00 p.m. Seconded by Councilmember Plett. All ayes: Councilmembers Kite, Sayles, York, Hilton, Plett, Waltman and Brewer. Motion carried and Resolution duly adopted.
- #5491. Councilmember Brewer moved to approve the Resolution approving the lease agreement with Thomas Simmons for leasing a portion of the Valley Street right-of-way for a ten year annually renewable lease at the rate of \$10.00 per year. Seconded by Councilmember Plett. All ayes: Councilmembers Kite, Sayles, York, Hilton, Plett, Waltman and Brewer. Motion carried and Resolution duly adopted.
- #5492. Councilmember Sayles moved to deny the request to park in the public right-of-way at 1206 First Avenue and 401 Monroe Street. Seconded by Councilmember Kite. Ayes: Councilmembers Kite, Sayles, Hilton and Waltman. Nays: Councilmembers York, Plett and Brewer. Motion carried.

Councilmember Hilton moved to approve the Resolution approving the request to park in the public right-of-way by the resident at 1100 West Third Street to utilize right-of-way in front of 402 Green Street at an annual fee of \$45.00. Seconded by Councilmember York. Ayes: Councilmembers Kite, York, Hilton, Plett, Waltman and Brewer. Nays: Councilmember Sayles. Motion carried and Resolution duly adopted.

Councilmember Brewer moved to approve the Resolutions setting public hearings on the requests to park in the public right-of-way at 1620 Hershey Avenue and 516 East Sixth Street for January 21, 1982, at 7:30 p.m. Seconded by Councilmember Kite. All ayes: Councilmembers Kite, Sayles, York, Hilton, Plett, Waltman and Brewer. Motion carried and Resolution duly adopted.

City Administrator Wolff reported that the Department of Housing and Urban Development had telephoned today to indicate their approval of the deductive alternates for the Sunset Park Housing Project with the exception of the fencing. Housing Administrator Jack Paetz reviewed the proposed site plan.

Councilmember Waltman moved to approve the Resolution approving the plans, specifications, form of contract, cost estimates and setting the date for receipt of bids (February 16, 1982) for the Sunset Park Public Housing Project. Seconded by Councilmember Hilton. Ayes: Councilmembers Kite, Sayles, York, Hilton, Plett and Waltman; Councilmember Brewer abstained. Motion carried and Resolution duly adopted.
- #5496. Councilmember York moved to approve the request to delay the repayment of the forgivable loan for Housing Rehabilitation Applicant No. 074 for $2\frac{1}{2}$ years. Seconded by Councilmember Hilton. All ayes; motion carried.
- #5497. Councilmember Waltman moved to approve the Resolution to discontinue the policy of permitting residents of the Clark House to move from one apartment to another if a vacancy occurs. Seconded by Councilmember Hilton. Ayes: Councilmembers Sayes, York, Hilton, Plett and Waltman. Nays: Councilmembers Kite and Brewer. Motion carried and Resolution duly adopted.
- #5498. Councilmember Kite moved to approve the Resolution amending the Clark House regulations establishing income requirements for admission to the Clark House based on total household income plus 10% of assets. Seconded by Councilmember Plett. All ayes: Councilmembers Kite, Sayles, York, Hilton, Plett, Waltman and Brewer. Motion carried and Resolution duly adopted.
- #5499. Councilmember York moved to approve the Supplement No. 2 to the lease with the FAA Master Site Lease for installation of a Single Frequency Outlet at the Municipal Airport. Seconded by Councilmember Brewer. All ayes; motion carried.
- #5500. Councilmember Plett moved to accept the bid of Alerting Communications of America in the amount of \$9,993 for purchase of three civil defense sirens. Seconded by Councilmember York. All ayes; motion carried.
- #5501. Councilmember Sayles moved to receive and file items A through I. Seconded by Councilmember Kite. All ayes; motion carried.
- #5502. Councilmember Hilton moved to approve bills totaling \$650,114.15 and authorize the Mayor and City Clerk to issue warrants of the same. Seconded by Councilmember Waltman. All ayes; motion carried.

Councilmember Waltman stated that he has received a request for a street light at the corner of Houser and Musser Streets.

Councilmember Plett reported receiving a complaint of ice on Second Street under the HON overpass in the northbound lane.

Councilmember Kite stated that he has received many favorable comments on the Street Department's snow removal activities.

Mayor Platt commended the City Council for the manner in which they conducted themselves during their first Council meeting.

#5503. Councilmember Waltman moved to adjourn the meeting. Seconded by Councilmember Hilton. All ayes; motion carried.
