AN ORDINANCE AMENDING TITLE 3 PUBLIC WAYS AND PROPERTY CHAPTER 9 STREET OBSTRUCTIONS.

Be It Enacted by the City Council of the City of Muscatine, Iowa:

SECTION 1. AMENDMENT. Title 3 PUBLIC WAYS AND PROPERTY, CHAPTER 9 STREET OBSTRUCTIONS of the City Code of Muscatine is amended to add a new Sections 5 and 6 to provide as follows:

- 3-9-5 <u>Dumping of Snow</u>: It shall be unlawful for any person to throw, push or place or cause to be thrown, pushed or placed, any ice or snow from private property, sidewalks or driveways onto the traveled way of streets so as to obstruct gutters or impede the passage of vehicles upon the street or to create a hazardous condition therein; except where, in the cleaning of large commercial drives in the business district, if it is absolutely necessary to move the snow onto the streets temporarily, such accumulation shall be removed within forty-eight (48) hours by the property owner or his agent, and only after first making arrangements for such prompt removal at the owner's cost of the accumulation within a reasonable short time.
- 3-9-6 <u>Penalty</u>: A violation of any sections of this chapter shall be a municipal infraction pursuant to the provisions of Section 1-2-7 of the Muscatine City Code.
- SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

Be It Enacted by the City Council of the City of

NUSCAUME, DWALL SECTION 1. AMENDMENT. Title 3 PUBLIC WAYS AND PROPERTY, CHAPTER 9 STREET OBSTRUCTIONS of the City Code of Muscatine is amended to add a new Sections 5 and 6 to provide as follows:

3:9-5 <u>Dumping of Snow</u>: It shall be unlawful for any person to throw, push or place or cause to be thrown, pushed or placed, any ice or snow from private property, sidewalks or driveways onto the traveled way of streets so as to obstruct gutters or impede the passage of vehicles upon the street or to create a hazardous condition therein; except where, in the cleaning of large commercial drives in the business district, if it is absolutely necessary to move the snow onto the streets temporarily, such accumulation shall be removed within forty-eight (48) hours by the property owner or his agent, and only after first making arrangements for such prompt removal at the owner's cost of the accumulation within a reasonable short time.

3-9-6 Penalty: A violation of any sections of this chapter shall be a municipal infraction pursuant to the provisions of Section 1-2-7 of the Muscatine City Code.

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutionally.

SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
