**Collections**: No report.

**Building & Grounds:** Mark Huddleston reported

1) **New Gun Law** – Barb Christensen raised the question whether there was a need to address the new gun law as it relates to the Art Center premises. Following discussion, the following resolutions were submitted for approval:

"RESOLVED, that the Muscatine Art Center will post signs on each entrance to the Art Center building prohibiting guns inside the Art Center buildings and on Art Center property.

'FURTHER RESOLVED, that the Muscatine Art Center will incorporated language into its contracts prohibiting guns inside the Art Center buildings and on Art Center property."

#### Finance & Budget: Caren Luke reported.

- 1) **Financials** The monthly financials for December 2010 reviewed. No action taken.
- 2) **2011/2012 Budget**. Budget hearing scheduled for Saturday, January 29, 2011 at City Hall (lower level). Bank with the understanding the Art Center will be responsible for on-going investment responsibilities. No action required.
