President, Tom Spread opened the meeting.

Permitting Fire Arms on Art Center Property: Gregg Mandsager, City Administrator, addressed the Board of Trustees regarding firearms on Art Center property. Mandsager provided the Trustees with a copy of Senate File 2379 enacted by the 2010 lowa General Assembly addressing this issue. No action taken.+

Minutes: It was moved by David Meloy, seconded by Jeffrey Stone to approve the minutes of the January 20, 2011, regular meeting as distributed. Motion carried.

Rescinding of Resolution: Based on the recommendation of the City Administrator, it was moved by Caren Luke and seconded by David Meloy, the resolution, in the minutes of January 20, 2011, prohibiting citizens from carrying guns inside the Art Center buildings and on Art Center property be rescinded. The motion passed with one (1) vote against. The Buildings & Grounds Committee will try and meet with a committee from the Musser Public Library to see if the Library board would like to jointly approach City Council about a firearms resolution.

Bills: It was moved by Caren Luke, seconded by David Meloy to approve payment of monthly bills totaling \$2,765.04. Motion carried. Tom Spread and Mark Huddleston signed the Schedule of Bills by Fund.

Credit Card Expenses - Monthly credit card expenses totaling \$290.88 were approved for payment. Tom Spread and Mark Huddleston signed the Monthly Log of Credit Card Expenditures.

Collections: Jan Henderson reported.

- 1) **lowa Legislation for Sale of Art** The Board discussed the ramifications of the lowa House subcommittee's vote in favor of legislation to sell the Pollock's Mural painting to fund student scholarships. The painting was donated in 1951 by Peggy Guggenheim to the University of Iowa. Members of the Board were encouraged to contact their local legislators.
- 2) **Wilmer Collection** Barb Christensen will prepare a press release announcing the receipt of the Wilmer Collection that is currently on display at the Art Center.

- 1) **Walkway Lights** The lights are still inoperable and pose a safety issue. Mark Huddleston will contact Randy Hill, Public Works Director, for solution to this problem.
