**An Ordinance Amending Title 2 Boards and Commissions,  
Chapter 19 Water, Electric and Communications Board of Trustees,  
Section 5 Trustee Requirements**

BE IT ORDAINED by the City Council of the City of Muscatine, Iowa, as follows:

Section 1. Title 2, Boards and Commissions, Chapter 19 Water, Electric and Communications Board of Trustees, Section 5 Trustee Requirements is hereby amended to read as follows:

2-19-5 Trustee Requirements. Each member of the Board of Water, Electric and Communications Trustees shall be a resident of the City of Muscatine with the exception of one member who may reside in either the water utility or electric utility service area provided by the Board of Water, Electric and Communications Trustees of the City of Muscatine. A public officer or a salaried employee of the City may not serve on the Utility Board.


Section 2. All ordinances or portions of ordinances in conflict herewith are hereby repealed.


