

ORDINANCE NO. 92277-0113

**AN ORDINANCE AMENDING THE ZONING ORDINANCE
OF THE CITY OF MUSCATINE, IOWA**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MUSCATINE,
IOWA AS FOLLOWS:

Section 1. That the boundaries of the District Map, being a part of the Zoning Ordinance, which is Title Ten of the Ordinance of the City of Muscatine, Iowa, be and the same are, hereby amended to rezone the following described real estate, situated in the City and County of Muscatine, and State of Iowa, to-wit:

ALL THAT PART OF THE NORTHEAST QUARTER (NE) OF SECTION EIGHTEEN (18) TOWNSHIP SEVENTY-SEVEN (77) NORTH, RANGE ONE (1) WEST OF THE FIFTH (5TH) PRINCIPAL MERIDIAN, SITUATED IN MUSCATINE COUNTY, IOWA LYING NORTH AND WEST OF U.S. HIGHWAY #61. EXCEPT 3.24 ACRES IN THE NORTHWEST CORNER THEREOF CONVEYED TO THE DAVENPORT & MUSCATINE RAILWAY COMPANY AND TO J.C. WOOD BY RIGHT OF WAY DEED RECORDED IN BOOK 57 OF LANDS PAGE 28 AND WARRANTY DEED RECORDED IN BOOK 55 OF LANDS, PAGE 499. ALSO THE SOUTH SIXTEEN AND ONE-HALF (16 1/2) ACRES OF THE SOUTHEAST QUARTER OF NORTHWEST QUARTER OF SECTION EIGHTEEN (18), IN TOWNSHIP SEVENTY-SEVEN (77) NORTH, RANGE ONE (1) WEST OF THE FIFTH (5TH) PRINCIPAL MERIDIAN. Said real estate be rezoned from Muscatine County M-2, A-1, and R-1 to the R-4 Residential District, upon annexation into the City of Muscatine.

Section 2. That all ordinances or parts of ordinances in conflict herewith are hereby repealed and this Ordinance shall be in full force and effect from and after its passage and publication as provided by law.




