

**RESOLUTION ACCEPTING COMPLETED WORK PERFORMED UNDER
IDOT PROJECT NO. 91150MUT100 – T-Hangar Connector Road Project**

WHEREAS, the City of Muscatine approved the Plans, Specifications, and Form of Contract for IDOT Project No. 91150MUT100 – T-Hangar Connector Road Project for the Muscatine Municipal Airport; and

WHEREAS, the City of Muscatine entered into a contract for said project with Muscatine Bridge Company, Inc. for \$139,767.80 with no change orders; and

WHEREAS, the City of Muscatine previously made one (1) payment of \$131,496.91 to Muscatine Bridge Company, Inc. for substantial construction completion; and

WHEREAS, work under said contract has been completed by Muscatine Bridge Co. Inc., and approved and accepted by Anderson-Bogert Engineers & Surveyors, engineers for the City as having met the requirements of the Plans and Specifications adopted by this Council; and

WHEREAS, the amount of \$1,282.50 is now due and payable to Muscatine Bridge Co. Inc., leaving a retainage of \$6,988.39 which is due and payable to Muscatine Bridge Co. Inc., thirty (30) days of approval of this Resolution,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MUSCATINE, IOWA, that the City hereby accepts all work under the IDOT Project No. 91150MUT100, T-Hangar Apron Drainage Project and hereby authorizes that payment be made to Muscatine Bridge Co., Inc., for \$1,282.50.

BE IT FURTHER RESOLVED that the final retainage payment of \$6,988.39, which represents 5% of project total, be paid to Muscatine Bridge Co., Inc., thirty (30) days from the date of the adoption of this Resolution.

INTRODUCTION: The City of Muscatine accepted a grant from the Iowa DOT to provide funding for the project identified as No. #91150MUT100 "T-Hangar Connector Road Project".

BACKGROUND: Following the preparations of plans and specifications, the project was bid and a contract was awarded to Muscatine Bridge Co., Inc., in the amount of \$139,767.80. The project was completed in May 2016.

RECOMMENDATION/RATIONALE: On May 9, 2016, the City was notified by the project engineer from Anderson-Bogert Engineers and Surveyors that all work has been completed and is ready for final acceptance by the City. It is recommended that the City Council take action to approve the attached resolution accepting final work and authorizing the final payment to Muscatine Bridget Co., Inc. for the work performed on T-Hangar Connector Road Project #91150MUT100.
