INTRODUCTION:

The City Council approved acceptance of bids for clean diesel equipment for Transit buses and Street Department vehicles at the February 7, 2013 meeting. This grant was awarded to Muscatine from the Department of Natural Resources for purchase and installation of diesel reduction equipment. The grant funding is not to exceed \$123,564.00.

BACKGROUND:

The original application included the following vehicles to be fitted with the diesel emission reduction equipment include: Transit buses 240,241,242,243,244, and 245. All of these are 2006 El Dorado, 176" light duty transit buses. The Street Department equipment on the original bid included: two tandem axle dump trucks and 3 single axle dump trucks. The vehicle numbers for the tandem axle trucks are 66 and 71. The single axle trucks are numbers 117, 136, and 153.

Upon reviewing our original application, the Department of Natural Resources advised us to add additional vehicles to utilize the full grant amount. Two refuse handlers, vehicle no's 431 and 436 were added. Two single axle dump trucks were also added, vehicle no.'s 50 and 114. During the pretest of equipment, we learned two transit buses #238 and #239 were not compatible with the diesel particulate equipment. It was recommended they be fitted with a CCV and DOC. This revision was made and then deleted when we learned buses #238 and #239 were to be replaced, via funding from another source.

RECOMMENDATION/RATIONALE:

It is our recommendation to have council approve p.o.'s. for Interstate Power Systems #38531 and Nelson Electric #38530.

BACKUP INFORMATION:

1. Interstate Power Systems bid for diesel particulate filters and back pressure monitors for transit equipment is \$58,320.00.
2. Interstate Power Systems bid for two, Diesel Particulate, Regeneration panels is \$5400.00.
3. Interstate Power Systems bid for nine, Diesel Oxidation Catalysts is \$13,933.62. And the accompanying Crankcase Ventilation Systems for nine, \$4770.45. Installation of these units \$7200.00.
4. Nelson Electric's bid for installation of the two regeneration panels is \$4500.00.
