Re: Bond/Schley Pump Station Renovation Project Change Order #2

INTRODUCTION: Attached is a request for Change Order # 2 for the Bond/Schley Pump Station Renovation Project. This change order provides for an increase of \$6,052.28 in the contract price.

BACKGROUND: During the renovation of these stations it was necessary to stop flow in order to remove station piping. A pipe plug ruptured during this operation delaying the plumbers from beginning work and need to be compensated for these hours while City staff worked on the problem. The piping also needed multiple unforeseen adjustments, additional pieces and creative welding to fit new equipment to the original installation. This change order was originally submitted as \$10,161.80. City staff negotiated with both contractors to reduce this amount to \$6,052.28.

Project construction was originally bid at \$297,300.00. With change order #1, City staff was able to reduce construction costs to \$259,505.00 with value engineering and other adjustments. Engineering and piping costs brought the total project cost to \$335,000.00 with only \$300,000.00 budgeted. With change order #2, the total project cost will be \$303,484.28. The project is complete and ready to be closed out.

RECOMMENDATION/RATIONALE: Staff recommends the city council accept this change order for \$6,052.28. Please include this item on the agenda for the August 18th Council Meeting.


