# AN ORDINANCE AMENDING TITLE 12, CHAPTER 2, SECTION 3(E) OF THE CITY CODE FOR MUSCATINE, IOWA

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MUSCATINE, IOWA, as follows:

Section 1. Section 12-2-3(E) is hereby repealed and the following enacted in lieu thereof:

- (E) In the rural residential area defined above, sidewalks shall be installed within the right-of-way on both sides of streets and cul-de-sacs. The subdivider shall install sidewalks according to the following specifications, or as may otherwise be required by the City.
  - 1. An excavation shall be made a full 5-feet (5') in width to a depth of four inches (4") below the finished grade of the walk; the subgrade shall be thoroughly compacted by mechanical means or hand tamping, and in such excavation shall be placed a concrete mix reaching four thousand (4,000) psi compressive strength in twenty-eight (28) days according to ASTM-39. Concrete sidewalks shall be a minimum of four feet (4') wide and four inches (4") thick.

Section 2. That all ordinances or parts of ordinances in conflict therewith are hereby repealed and this Ordinance shall be in full force and effect from and after its passage and publication as provided by law.

1. An excavation shall be made a full 3-feet (5') in width to a depth of four inches (4") below the finished grade of the walk; the subgrade shall be thoroughly compacted by mechanical means or hand tamping, and in such excavation shall be placed a concrete mix reaching four thousand (4,000) psi compressive strength in twenty-eight (28) days according to ASTM-39. Concrete sidewalks shall be a minimum of four feet (4") wide and four inches (4") thick.
