

ORDINANCE NO. 89498- 0805

AN ORDINANCE AMENDING TITLE 11, CHAPTER 1, SECTION 3 OF THE
CITY CODE FOR MUSCATINE, IOWA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MUSCATINE, IOWA, as follows:


Section 1. Section 11-1-3 Requirements of Preliminary Plat be amended to add:

- (O) Suitable public right-of-way for bicycle/pedestrian paths shall be carefully considered and required on the preliminary plat when they are compared with the Comprehensive Plan or designated as a part of the Running River Trail system as it may be amended from time to time. All such paths indicated on the final plat shall be installed by the City at such time as funds are available to the City for construction of the paths. All rights-of-way for bicycle/pedestrian paths shall be not less than twenty (20) feet wide.

Section 2. That all ordinances or parts of ordinances in conflict therewith are hereby repealed and this Ordinance shall be in full force and effect from and after its passage and publication as provided by law.


