SUBJECT

Third and Final Reading of an Ordinance Vacating Alley Right of Way Located Between 1248 and 1300 E. 5th Street

EXECUTIVE SUMMARY

Presented for City Council's consideration is the third and final reading of an ordinance vacating the alley right of way between 1248 and 1300 E. 5th Street. The City of Muscatine has submitted a request to vacate the alley right of way, and deed said right of way to the adjoining property owners.

STAFF RECOMMENDATION

Staff recommends approval of the second reading of this ordinance to vacate alley right of way. The alley is currently improved and open to traffic. The approval of this vacation would permanently close this alley to traffic.

BACKGROUND/DISCUSSION

The City of Muscatine has filed for the vacation of the right of way comprising the alley between 1248 E 5th St and 1300 E 5th St. The intent, if the request is approved by the City Council, of the City of Muscatine is to deed the vacated right of way to the adjacent property owners. The alley is currently improved and open to traffic. The approval of this vacation would permanently close this alley to traffic. Currently on E 5th Street, there are three alleys being used by the residents in the area. This alley is heavily used and in the worst condition. The owner located at 1300 E 5th St has had the retaining wall hit several times and would like to eventually repair it. The alley sits at the bottom of E 5th coming down a hill right before a curve and is dangerous for traffic pulling on or out of the alley due to not being able to see oncoming traffic.

CITY FINANCIAL IMPACT

This right of way is being proposed for vacation for safety and maintenance purposes. Vacating and deeding of this right of way to the adjacent property owners will benefit the community by allowing residents to enhance the appearance of the area as well as grow the tax base.
