AN ORDINANCE AMENDING TITLE 7 POLICE REGULATION CHAPTER 24 WEAPONS SECTION 5 RELATING TO BOW HUNTING OF DEER WITHIN THE CITY LIMITS

Be It Enacted by the City Council of the City of Muscatine, Iowa:

SECTION 1. AMENDMENT. Title 7 POLICE REGULATIONS, Chapter 24 WEAPONS, Section 5 Bow Hunting Deer - Exception, Sub-section (C) of the City Code of Muscatine which currently provides as follows:

(C) The person has a license or permit required by the State of Iowa to hunt deer with a bow.

is hereby amended to provide as follows:

(C) The person has a license or permit required by the State of Iowa to hunt deer with a bow.

SECTION 2. AMENDMENT. Title 7 POLICE REGULATIONS, Chapter 24 WEAPONS, Section 5 Bow Hunting Deer - Exception, Sub-section (D) of the City Code of Muscatine which currently provides as follows:

(D) The person has a permit issued by the Muscatine City Clerk.

is hereby amended to provide as follows:

SECTION 3. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 4. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional

SECTION 5. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.


