

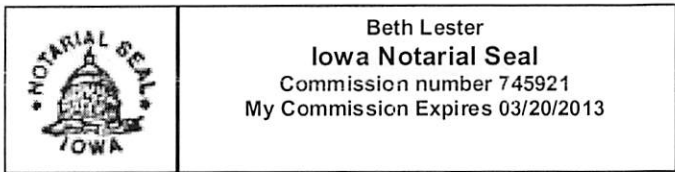

SUBJECT: Resolution approving plans, specs, form of contract, cost estimate, and setting bid opening date for the South End Fire Station Project

INTRODUCTION:

Requesting City Council to adopt resolution approving plans, specs, form of contract, cost estimate, and setting bid opening date for the South End Fire Station Project.

BACKGROUND:

The Muscatine Fire Department has been involved in a new Southend Fire Station project since May of 2009 and plan on breaking ground in March of 2011.

The construction cost estimate for this project is \$1,300,500.00 for a 9,850 square foot fire station with \$850,250.00 from the I JOBS II Grant, \$ 200,000.00 from the Iowa Department of Economic Development Grant, and the city's share of the project is \$ 250,250.00 from the General Obligation Construction Bond.

The public hearing is proposed for the February 3rd, 2011 City Council meeting in anticipation of a March 3rd, 2011 bid opening date.

It is anticipated to begin construction towards the end of March 2011, with an estimated completion date of December 2011.

RECOMMENDATION/RATIONALE:

Recommend that City Council adopt the resolution to approve the plans, specifications, form of contract, cost estimate, and setting the bid opening date for the South End Fire Station Project.
