**WHEREAS**, The City Council has for the City of Muscatine, Iowa, has undertaken several improvement projects at the Muscatine Municipal Airport; and

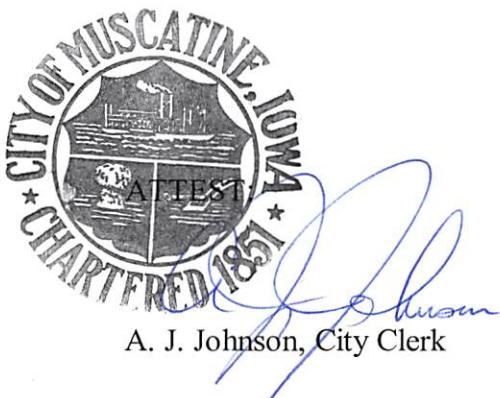
**WHEREAS**, The City of Muscatine has received approval to proceed with the preparation of specifications, cost estimate, form of contract and establishing a bid opening date related to the acquisition snow removal equipment for the Muscatine Municipal Airport known as “AIP No. 3-19-0063-14”; and


**WHEREAS**, The estimated cost of \$157,894.00 for the equipment will be paid through 95% federal and 5% local funding; and

**WHEREAS**, The City Council wishes to conduct a public hearing concerning the specifications, cost estimate and form of contract prior to establishing a bid opening date,

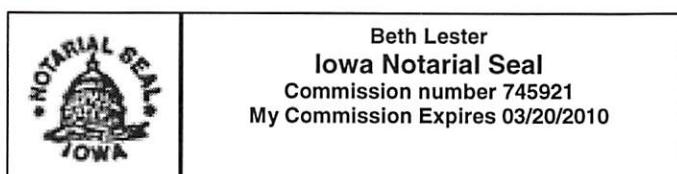

SUBJECT: Snow Removal Equipment Purchase / Municipal Airport

DATE: February 12, 2008

Recently the City of Muscatine was notified by the Federal Aviation Administration (FAA) that funding would be made available to acquire snow removal equipment for the Muscatine Municipal Airport. The funding would allow the City to purchase specialized snow removal equipment meeting specifications approved by the FAA. The new equipment would supplement and/or replace the worn out 1991 Ford L8000 Diesel Truck and 12-foot Coates plow originally used by the Department of Public Works.

Prior to the advertising of bids for the purchase of this equipment, a public hearing is required. Therefore I am attaching a resolution to set a public hearing to consider the specifications, cost estimate, form of contract, and to establish a bid opening date related to the acquisition of snow plow equipment for the Muscatine Municipal Airport.

As with other funding authorized by the FAA, the acquisition of this equipment would be paid through a 95% federal and 5% local share.

Please place this matter before City Council for their consideration during the February 21, 2008 meeting.
