**(Cobblestone Ridge Replatting - Phase II Final Plat)**

WHEREAS, there has been filed with the Planning and Zoning Commission of the City of Muscatine, Iowa, and there is now submitted to the City Council of said City, a Final Plat of the real estate described on attached Exhibit A ("Real Estate"), which is situated within the corporate limits of the City of Muscatine, County of Muscatine, State of Iowa;

WHEREAS, said Final Plat lays out and subdivides the Real Estate into two (2) lots within the City of Muscatine, Iowa,

WHEREAS, said Final Plat has been approved by the Planning and Zoning Commission of the City of Muscatine, Iowa, and has been examined by the City Council of the City of Muscatine, Iowa,




