The City's Purchasing Agent shall open the proposals received and announce the results at 10:05 a.m. on October 29, 2003.

SECTION III: The City Clerk is directed to give notice of such reception of bids by publication of a notice in the Muscatine Journal, more than twenty (20) but not more than forty-five (45) days prior to the date for reception of bids. The notice shall be in the following form:



The project shall consist of exterior renovation of the Musser building including cleaning, repairing, repointing masonry and sealing stonework, painting trim, re-glazing windows, replacing rotted wood and replacing 76 storm windows.

Proposals shall be submitted on a form furnished by the City and accompanied by a bid security in an amount equal to ten (10) percent of the bid and shall stand as security that the successful bidder will enter into a contract for the work bid upon within ten (10) days after acceptance of his proposal by the City.

The City reserves the right to defer acceptance of any proposal for a period not to exceed thirty (30) calendar days and to reject any and all bids, to waive technicalities and to enter into such contract as it shall deem for the best interest of said City.



The City Council set a Public Hearing for October 2, 2003 regarding the Muscatine Art Center Exterior Restoration Project. Also on the Council Agenda is a Resolution Approving the Plans, Specifications, Form of Contract, Cost Estimate and Setting a Date for Receipt of

Bids.

This project has been approved by the City Council and \$84,000 has been authorized for it. \$42,000 will be provided by the City and \$42,000 will come from the Art Center. The work involves an exterior renovation of the Musser building including cleaning, repairing, re-pointing masonry and sealing stonework, painting trim, re-glazing windows, replacing rotted wood and replacing 76 storm windows.
