AN ORDINANCE AMENDING TITLE 5 BUSINESS REGULATIONS, CHAPTER 3 BEER AND LIQUOR, SECTION 18 PROHIBITED SALES AND ACTS

Be It Enacted by the City Council of the City of Muscatine, Iowa:

SECTION 1. AMENDMENT. Title 5 BUSINESS REGULATIONS, CHAPTER 3 BEER AND LIQUOR, SECTION 18 PROHIBITED SALES AND ACTS of the City Code of Muscatine, is hereby amended to add the following new Subsection (I) AMATEUR FIGHTING AND BOXING:

(I) AMATEUR FIGHTING AND BOXING.

- 1. No person, individual, association, corporation, partnership or club holding a liquor control license, wine or beer permit, which authorizes on the premises consumption, nor his or her agents or employees shall allow an amateur fighting or boxing match to occur on said premises.
- 2. No person shall participate in an amateur fighting or boxing match in an establishment holding a liquor control license, wine or beer permit, which authorizes on the premises consumption.
- 3. No person shall promote, advertise, or organize an amateur fighting or boxing match in an establishment holding a liquor control license, wine or beer permit, which authorizes on the premises consumption.
- 4. "Amateur fighting and boxing match" means a boxing, wrestling, mixed martial arts fighting, extreme fighting, ultimate fighting or shoot fighting match, contest, event or exhibition for which the contestants are not paid or awarded a prize for their participation.
- 5. Any violation of this section shall be considered a municipal infraction punishable by a civil penalty of seven hundred fifty dollars (\$750.00) for first offense and one thousand dollars (\$1,000.00) for second and subsequent offenses.
- SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
- SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional
- SECTION 4. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

No person, individual, association, corpora tion, partnership or club holding a liquor control license, wine or beer permit, which authorizes on the premises consumption, nor his or her agents or employees shall allow an amateur fighting or box ing match to occur on said premises.

2 . No person shall participate in an ame fighting or boxing match in an establishment hold-ing a liquor control license, wine or beer permit, which authorizes on the premises consumption.

3. No person shall promote, advertise, or organize an amateur fighting or boxing match in an establishment holding a liquor control license, wine or beer permit, which authorizes on the premises consumption.

4. "Amateur fighting and boxing match" means a boxing, wrestling, mixed martial arts fighting, extreme fighting, ultimate fighting or shoot fighting match, contest, event or exhibition for which the contestants are not paid or awarded a prize for their participation.

5. Any violation of this section shall be considered a municipal infraction punishable by a civil penalty of seven hundred fifty dollars (\$750,00) for first offense and one thousand dollars (\$1,000.00) for second and subsequent offenses

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any si tion, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional

SECTION 4, WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
