## AN ORDINANCE VACATING AND TRANSFERRING CITY RIGHT-OF-WAY AND REAL ESTATE IN THE CITY OF MUSCATINE, IOWA.

WHEREAS, the City of Muscatine Planning and Zoning Commission has reviewed a request to vacate and transfer public property remnants and rights-of-way located within the Grain Processing Corporation (GPC) industrial campus; and

WHEREAS, the City of Muscatine's Planning and Zoning Commission has determined there is no anticipated future use of these remnant rights-of-way and public property, except the reservation of a right-of-entry to maintain existing utilities; and

WHEREAS, the City Council of the City of Muscatine has conducted a public hearing on said vacation request;
