President, Tom Spread, opened the meeting.

Visitor: Rachel Schmaltz, a student majoring in graphics design, was present as an observer.

Minutes: It was moved by Mark Huddleston, seconded by Jennifer Conard to approve the minutes of the **May 20, 2010** regular meeting as presented. Motion carried.

Bills: It was moved by Caren Luke, seconded by David Meloy to approve for payment monthly bills totaling \$8,029.18. Motion carried.

COMMITTEE REPORTS

Collections: Jan Henderson reported.

1) Tangley cabinet radio was gifted by David Gillaspie, Hiawatha, Iowa.

Building & Grounds: Mark Huddleston reported.

- 1) Landscape project for property at 1402 Mulberry Avenue. The work on the project has been delayed due to rain. BMW Builders is working on the brick replacement. Barb Christensen will meet with the Public Works Department on Friday, June 18, 2010, to discuss clearing the lot.
- 2) Security/Fire Alarm System The Committee recommended the Board approve the bid from Integrated Technology Partners (ITP), Wilton, Iowa in the amount of \$41,781.00, but not to exceed \$47,800.00, which includes a one-year Maintenance Agreement. This project will be paid out of funds already budgeted in the Support Foundation (\$32,000.00) with the balance coming from the Brad Burns Trust.

Finance & Budget: Caren Luke reported.

Monthly Financials - The May 2010 monthly financial reports were received and reviewed.

Long-Range Planning: No report. It was noted, due to the state of the economy, when the new Long Range Planning Committee is formed, they should focus on funding of the Art Center operations in the future.

Personnel: Barb Christensen reported.

1) Registrar Position - Barb met with City Administrator Gregg Mandsager regarding changing the Registrar position from three-fourths time to full time. This would be accomplished by eliminating the Education Coordinator position formerly held by Maria Horton who retired on June 5, 2010. Gregg Mandsager asked Barb to provide a formal commitment from the Art Center Board of Trustees to the City of Muscatine to fund this position. Gregg will include this request on the agenda for the July in-depth session.

Following discussion, it was moved by Eric Knoernschild and seconded by David Meloy that the Muscatine Art Center Board of Trustees agrees to formally commit funding from the Muscatine Art Center Support Foundation for 10 hours a week and 25% of the fulltime benefits for the Registrars position. Motion carried.
