This meeting is for the purpose of annexing approximately 105+ acres of real estate adjacent and east of the existing corporate limit line more specifically described as follows:

Part of the Northwest Fractional Quarter of Section 19, Township 77 North, Range 1 West of the 5th Principal Meridian, described as follows:

Beginning at the northwest corner of said Fractional Quarter Section 19, thence North 88 degrees 54 minutes 26 seconds East, 1955.05 feet on the north line of said Fractional Quarter Section to the east line of the West Half of said Fractional Quarter Section; thence South 01 degrees 02 minutes 49 seconds East, 2662.54 feet to the south line of the West Half of said Fractional Quarter Section; thence South 89 degrees 28 minutes 33 seconds West, 1030.12 feet on said line to the east right of way of University Drive; thence North 01 degrees 12 minutes 10 seconds West, 998.47 feet on said east right of way line to the centerline of Primary Road No. U.S. 61; thence South 53 degrees 31 minutes 28 seconds West, 1145.65 feet on said centerline to the west line of the West Half of Fractional Quarter Section 19; thence North 00 degrees 46 minutes 06 seconds West, 2317.26 feet on said line to the point of beginning, containing 105.227 acres, more or less.

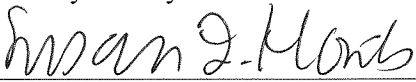

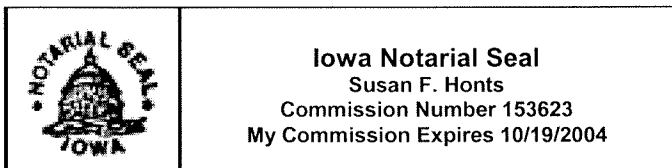
