**SET TIME AND PLACE FOR PUBLIC HEARING ON THE
2011 STREET IMPROVEMENTS PROJECT**

WHEREAS, the City Council of the City of Muscatine, Iowa has heretofore granted preliminary approval of the plans, specifications, form of contract, and cost estimates for the proposed 2011 Street Improvements Project; and

WHEREAS, the proposed project is to be paid for out of funds legally available for that purpose;

NOW, THEREFORE, be it resolved by this Council that:

SECTION I: On April 21, 2011 at 7:00 p.m. in the City Council Chambers at City Hall, Muscatine, Iowa, this Council shall hold a public hearing of the plans, specifications, form of contract, and cost estimates for this proposed project.

SECTION II: The City Clerk shall give notice of such public hearing by publication of a notice in the Muscatine Journal not less than four (4) nor more than twenty (20) days prior to the date set for the hearing. The notice shall be in the following form:



INTRODUCTION:

The Roadway Maintenance Division has \$625K available for street improvements until June 20, 2012. We are request a Public Hearing be set for the 2011 Street Improvements Project.

BACKGROUND:

\$125K is still available from the 2010 Street Improvements Program and an additional \$500K is allocated in the 2011 budget for street work. These funds are from the One Cent Local Option Tax.

RECOMMENDATION/RATIONALE:

\$456K will be allotted for overlay work. The streets include:

- a. Laurel Street (Park Ave. – Fairview)
- b. Fourth Street (Park Ave. – Fairview)
- c. Monroe Street (Park Ave. – Dead End)
- d. Tenth Street (Chestnut – Iowa Ave.)
- e. Seventh Street (Poplar – Dead End)
- f. Mulberry Ave. (2nd – 8th)
- g. Highland Court (Dawson St. to Dawson St.)
- h. Young Ave (Parham – Hospital)

All of these streets have a Pavement Condition Index of 47 or less.

\$69K will be allocated to Full Depth Patching. The focus will be on Logan Street from Cedar to Fulliam. This area is chosen because of future detour routing when Cedar Street is under

construction. We recommend the City Council set a Public Hearing for the 2011 Street Improvements Project at the April 21, 2011 meeting.
