AN ORDINANCE AMENDING TITLE 1, ADMINISTRATIVE, CHAPTER 6 MAYOR AND CITY COUNCIL, SECTION 2 SALARY OF MAYOR, AND SECTION 5 SALARY OF CITY COUNCIL

Be It Enacted by the City Council of the City of Muscatine, Iowa:

SECTION 1. AMENDMENT. TITLE 1 ADMINISTRATIVE, CHAPTER 6 MAYOR AND CITY COUNCIL, SECTION 2 SALARY OF MAYOR and SECTION 5 SALARY OF CITY COUNCIL of the City Code of Muscatine which currently states:

- 1-6-2 <u>Salary of the Mayor</u>. The Mayor shall receive, in full compensation for his or her services, a salary of Six Thousand Five Hundred Dollars (\$6,500) per year effective January 1, 2010; and
- 1-6-5 <u>Salary of City Council</u>. Each Council member shall receive in full compensation for his or her services, a salary of Four Thousand Dollars (\$4,000) per year effective January 1, 2010,

are hereby amended to state as follows:

- 1-6-2 <u>Salary of the Mayor</u>. The Mayor shall receive, in full compensation for his or her services, a salary of Seven Thousand Dollars (\$7,000) per year effective January 1, 2016; and
- 1-6-5 <u>Salary of City Council</u>. Each Council member shall receive in full compensation for his or her services, a salary of Four Thousand and Four Hundred Dollars (\$4,400) per year effective January 1, 2016.
- SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
- SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional
- SECTION 4. WHEN EFFECTIVE. This ordinance shall, after its final passage, approval and publication as provided by law, take effect on January 1, 2016.
